Identify Data of the Owner of the Site

This information that is published under the domain names www.quintasenergy.com and www.quintasenergy-asemanagement.com forms and regulates the conditions of use, disclaimers, and obligations that users of the site must accept and commit to respect.

In any case, the conditions of use, disclaimer, and privacy policy written in Spanish will withstand against any interpretation of them in any other language that could give rise to confusion.

Definitions

Site: www.quintasenergy.com, domain that Quintas Energy makes available to Internet users

User: natural or legal person using or browsing the site

Content: pages that make up the entire domain www.quintasenergy.com and contain the information and services that Quintas Energy makes available to Internet users in the form of messages, text, photographs, graphics, icons, logos, technology, links, textures, drawings, sound files and/or images, recordings, software, appearance, graphic design and source codes and, in general, any kind of material contained on the site.

Web: technical word describing the system of access to information via the Internet, which is configured through pages made with HTML or a similar language, and describing the programming mechanisms such as Java, JavaScript, PHP, or others, etc. These pages are designed and published under an Internet domain name that is the result of the information that the owner makes available to Internet users.

Hyperlink: technique by which the user can browse through different web pages, or through Internet, with a simple click on the text, icon, button, or indication that contains the link.

Cookies: technical word that means "traceability" and tracking of the navigation on web sites. They are small text files that are written into the user's computer. This method has privacy implications, so Quintas Energy will duly notify their use when they are implemented on the site.

Terms of Use

The simple and mere use of the site grants the condition of user of the site, either a natural or legal person, and necessarily implies full, complete, and unreserved acceptance of each and all

of the terms and conditions included in the Legal Notice. If the user is dissatisfied with the terms and conditions of this Legal Notice he/she shall not use the Site.

This Legal Notice is subject to changes and updates so the version published by Quintas Energy may be different each time the user accesses the site. Therefore, the user must read the Legal Notice each and every time he/she access the site.

Cookies
